

# **ASORC & RCAA MERGER**



The Australian Society of Rehabilitation Counsellors (ASORC) and the Rehabilitation Counselling Association of Australasia (RCAA) merged on the 12th December 2023 to create a stronger, more unified voice. We thank the Directors of ASORC and RCAA for their dedication and hard work to ensure a seamless transition.

#### Background

Building on the productive outcomes of collaborations between ASORC and RCAA (since 2021) a merger was proposed, and steps were taken for the two entities to combine to form a single entity. The proposed merger and required changes to the Constitution were approved by members of ASORC at the AGM in November 2023 and subsequently by members of RCAA at a Special General Meeting in December 2023. The merger became official on the 12 December 2023 and the transition processes and administrative requirements to effect the merger followed.

A transitional Board for the merged entity (ASORC) was established with 10 Directors, 5 from ASORC and 5 from RCAA. The first Board meeting was held on 22-23 February 2024 where the strategic priorities were confirmed.

ASORC and RCAA members, who accepted the new Constitution and membership requirements, became Full Members of the merged entity (ASORC) ensuring continuity of their professional recognition.


In May 2024, RCAA held another Special General Meeting where members voted to voluntarily de-register the entity RCAA and this process is now complete.

#### **Future**

As a merged entity we are able to progress work that enables the profession to continue to meet the current and future needs of consumers, employers, and the community. We will also be able to better represent the profession in communications with governments, peak bodies, and industry, and will strengthen the profession's voice in education and practice settings as well as working with industry to address Rehabilitation Counsellor labour shortages in Australia.

# **MEMBER UPDATE**






#### **Associations Forum Hall of Fame Award - Stephen Hughes**

# **NEW INITIATIVES**



#### **ASORC Forensic Vocational Assessment (FVA) Certification**

The Forensic Vocational Assessment (FVA) working group is led by Project Coordinator and ASORC Fellow, Dr Margaret Black, and includes Dr Mary Barros-Bailey (Fulbright Specialist and Forensic Expert), Jessica Cucchiaro (ASORC Director) and Bernadine Euers (ASORC CEO). ASORC has been privileged to work with Dr Barros-Bailey, who has so generously shared her time and expertise to the development of the program. We sincerely thank Dr Margaret Black, Dr Mary Barros-Bailey and Jessica Cucchiaro and the many contributors to the panels and modules. The program is in its final stages and we are proud to announce this course will be certified by the Commission on Rehabilitation Counselor Certification (CRCC).

#### **ASORC Professional Supervision Program endorsement**

The ASORC Professional Supervision Program (APSP) is designed to develop the skills and knowledge required of a Rehabilitation Counsellor. The endorsement for the APSP is an important acknowledgement that recognises Workplace Rehabilitation Providers who are delivering high standards of supervision for ASORC Associate members to achieve the competencies required for practicing as a Rehabilitation Counsellor. Supervision under the APSP reflects both current practice and industry requirements, while providing a depth and breadth of experience to enable the member to develop the skills and knowledge required. We congratulate Pinnacle Rehab as the first Workplace Rehabilitation Provider with ASORC Professional Supervision Program endorsement.

#### **Short courses**

ASORC will be launching a number of short courses, including Vocational Assessment, Forensic Vocational Assessment and the Biopsychosocial Model. We thank ASORC Director Danielle Murphy and Dr Pam Garton for sharing their insights and expertise in the development of these important courses.

#### ASORC Learning Management System

ASORC members will soon have access to these exciting new courses via an online Learning Management System (LMS).
